Dear Members.... 42 Traverse is CLOSED

4WD vehicles are restricted to the summer months from 1st December to 30th April. Thank you to the volunteers who keep this track open.

Acheron Road is **CLOSED**

Located in Molesworth Station in the Marlborough region Between Labour weekend and early April, you can drive through Molesworth Station on the Acheron Road.

Maratoto is **CLOSED**

All off road tracks in the Maratoto area are now CLOSED to ALL vehicles. This includes the Whangamata (Wires) Track, Loop Road, Waipaheke and all tracks off these tracks. This closure is by order of the Department of Conservation and is due to Kauri Die Back.

Old Whangamomona Road is CLOSED

The Old Whangamomona Road is closed from 1st May until the 31st October. Thank you to the volunteers who keep this track open.

Rainbow Station Road is CLOSED

Rainbow Station Road is now CLOSED to the public for the offseason due to winter weather conditions and farm operations. The road is often unpassable and the gates are locked. The road normally re-opens for public access on Boxing Day 26th December 2018.

Waitawheta 4WD track CLOSED

UPDATE BY Russell De Luca - Northern Zone PRO


We have recently lost the sanctioned use of the iconic Waitawheta 4WD track located in the Northern Zone, west of Waihi town.

Because of concerns relating to sedimentation of adjacent streams allegedly caused by 4WD activity, the track has been closed by DOC and the Hauraki District Council (HDC). This is notwithstanding that NZFWDA Northern Zone members have over the past five or more years spent an inordinate amount of their own time, effort and expense collaborating in good faith with staff of the constituent authorities in the carrying out of works to upgrade the standard of the track and to thereafter implement an ongoing management and maintenance plan so as to enable the track to be reopened to 4WD use.

It recently became apparent that the opposition of the Waikato Regional Council (WRC) to resumed 4WD activity had caused DOC and HDC to change their previously helpful positions. The upshot of this was that in May of this year we were advised that we would need to obtain a resource consent in order to undertake further track upgrade works and to thereafter allow 4WD activity to officially resume. This is notwithstanding that previous advice from WRC staff was that no such resource consent would be required. The costs associated

with the requirement to apply for a resource consent (which may or may not be granted) is beyond the means of the Northern Zone and the on-going risks associated with being the legal holder of the consent (if granted) would have been unacceptable.


The ironic result of this is that unauthorised 4WD (and other) activity of the Waitawheta track will continue to occur in an uncontrolled manner thereby creating far greater adverse effects on the environment than those which would have resulted from managed 4WD activity as offered through the Northern Zone proposal.





AKATARAWA FOREST BLOCK

Ongoing

- Caution is required when driving on all the forests roads. Hazards may include fallen trees, washouts debris and slips.

- Extra care needed when using all ford crossings.

- Cannon Point walkway Tulsa Park Via Zig Zag to Trig is CLOSED to all public access

- 6km Valley View short cut track to 7km Airstrip is closed.

PLANTATION FORESTRY

Valley View Forest

- Planting to occur on Spring Road and Lyndsays Road beyond the 12km marker. From 20th June.

 Logging traffic along Valley View Road between 4am and 5pm weekdays. Radio communication on these roads at all times.

Puketiro Forest

- Tree planting due to commence on Main Loop Rd and Puketiro Road from 20th June. Beware of additional vehicles and people around these roads.

- Road maintenance Puketiro Road, Rallywoods Rd, Main Loop Rd.

- Harvesting Main Loop Road area. No access to this area while harvesting in progress. This operational area off limits to recreational use at all times. Harvesting will also be taking place alongside Rallywoods Road at the 12K. Remain on Rallywoods and do not approach operational area.

- Harvesting and road construction taking place in the Cooks Ridge Road area for some weeks beginning in late May. No access to this area while harvesting is in progress. This operational area is off limits to recreational use at all times.

- Controlled burn planned for Puketiro Forest, Main Loop Rd. Burn active at marker 4 Main Loop Rd. Stay clear of this area at all times.

The speed limit in the Forest is 30kph, Please ensure that you obey this limit.

Not all vehicles are equipped with radios – Drive to stop in half the clear distance ahead.

All vehicles must have headlights on in the forest.

BEWARE OF MOUNTAIN BIKES AND PEDESTRIANS ADJACENT TO LOGGING ROADS.

All vehicles MUST give way to loaded logging trucks.

NZFWDA FOREST & RURAL FIRE LIABILITY INSURANCE COVER

Hello all,

Just to confirm where NZFWDA stands on Forest and Rural Fire liability from perspective of insurance cover for 2018 onwards.

We have previously held specific insurance for Forest and Rural Fires Act 1977 which covered risk liability of NZFWDA and members if held responsible for causing a rural fire (Section 43 of the 1977 Act).

In July 2017 the Fire and Emergency New Zealand Act 2017 (FENZ Act) repealed the 1977 Act and effectively replaced S 43 with a new offence and penalty regime that includes maximum penalties of:

- Imprisonment for up to two years, and/or

- Fines of up to \$300,000 for an individual and \$600,000 in any other case

The FENZ Act does not have the same financial liability as was present under the 1977 Act but, in addition to the penalties outlined above, under FENZ, those who suffer loss because of rural fire will need to establish a common law cause of action to recover compensatory damages. Much more will be required for successful recovery than simply proving the cause of a fire; that means those who suffer losses as result of a fire need to establish the person(s) who caused the loss did so recklessly or negligently.

Consequently the need for a separate Forest and Rural Fire sublimit has been overtaken by the FENZ Act. For NZFWDA we have continued to have Forest and Rural Fire sublimit cover of \$2M shown on our insurance certificate in case of claims under the now repealed 1977 Act. This sublimit cover will drop off our Certificate probably by next issuance date. What we now have is a significantly increased Public Liability of \$10,000,000 to cover compensatory damages claims and we have Statutory Liability of \$1,000,000 to cover any fines etc...... additionally we now also have legal defence cover of \$500,000.

NZFWDA and our members are not covered (and never have been) for gross negligence; in simple terms this means that if Clubs / members act irresponsibly or foolishly then they will find themselves on their own (there's no cover for stupidity).....so usual rules of engagement for club events will need to prevail ie Club sanctioned event / allocated trip leader / all participants documented and signed in as "members", normal risk assessment and management plans advised / etc......

A key takeaway for our members is that any action arising from breach of the FENZ Act will most likely be sheeted home firstly to an individual but compensatory damages claims may well be against a collective; the stated objective of the new legislative regime is "to improve fire safety" but it remains to be proven that serious criminal penalties will deter risky fire behaviour. For NZFWDA members we probably have an increased need to be aware of and manage and/or control the actions of individuals who, by their actions, might be perceived to be contributing to increased risk (think things like lighting a bbq or fire in the middle of a forest during a fire ban or throwing a used cigarette out the window of a truck.....)

President's Report NZFWDA AGM 2018

Before I get into my annual report as President of NZFWDA I am deeply saddened to advise the death on Thursday of Steve McMinn who had travelled to Invercargill with Barbara to attend this meeting. Many of you will know and respect Steve for his longstanding commitment to and active participation in all facets of 4 wheeling including involvement in the initial establishment of NZFWDA in the 1970's. Steve (commonly known as Duk) spent many active years competing in the National Trial series and more recently was known for his role as Jeep Ambassador following the reintroduction of that margue to NZ. I know Steve will be sorely missed by Barbara and family and friends and also by our wider 4WD family; Steve made some big impacts on NZFWDA and the broader 4WD movement. To Barbara and family I offer my personal and our collective condolences.

I started writing this report as I made my way down and across the South Island of this wonderful country we call home; destination Invercargill. John McDonald was the organizer of this run and, as usual, John's organization has been superb. I want to acknowledge John's efforts and I know I also speak for the other participants in the 2018 President's Run from the top of the South to the bottom of the South. Maybe we should make this an annual event immediately preceding each AGM?? Next year of course Central Zone is hosting another National Jamboree.....

I begin this report by offering my thanks to your National Executive who have continued to offer their significant individual and collective skills and commitment to the operation of NZFWDA. As previously mentioned I think it is often easy for folk to forget the Executive are all volunteers who offer to take on roles which oftentimes involves significant personal time commitment at expense of family or work commitments. My thanks to all the executive and also my personal acknowledgments to Southern Zone President Russell Quin, Southern Zone PRO John McDonald, and National Secretary Bobbie Kincaid, who are retiring their roles at close of this meeting.

I also need to advise the past 12 months have been particularly difficult for me from a personal health perspective and I wish to declare my gratitude for the extra support from the other Executive members whilst I have perhaps been a tad below par; thank you.

From a financial perspective NZFWDA remains in good financial health; the FS for YE 31/3/2018 disclose reduced incomes but also reduced expenses from last year and whilst our actual result is an accounting profit of \$992 this includes non-cash depreciation of \$ 1,171 so our actual operating profit for the year was \$2,163.

Over the past few years we have sorted some of the most glaring ambiguities in the Constitution and also clarified, by constitutional amendments, the status of various membership classes; individual, family, and day member. These things now provide a strong platform for member clubs to appropriately engage with existing / renewing members as either individual or family, and to ensure that day membership is available for temporary or trial members. The underlying reason for these changes has been to ensure that everyone participating in NZFWDA sanctioned events is covered by our liability insurances.

Following the repeal of the Rural and Forest Fire Act 1977 it was necessary for us to review NZFWDA insurance coverage effective for year commencing February 2018; what we now have is significantly increased cover for Public Liability to \$10M, new legal defense cover to \$500K, and statutory liability cover to \$1M.

The HSWA reported in 2016 continues to be an elephant under the carpet and this year the Executive have continued their work to develop and release appropriate guidelines for Clubs and members. We will be presenting to this meeting our outcomes from this work, which has involved enormous amounts of time from all executive but especially John Hickey, Grant Purdie, and myself. Whilst preparing our final HSWA guidelines for release to this meeting we also sought legal review by Kensington Swan and Duncan Cotterill. The combined external legal costs came to about \$6,500 and we believe we obtained very good value for money from these separate reviews. More on HSWA and NZFWDA response to follow in this meeting

Work on Constitutional changes was somewhat sidelined by our efforts to produce H&S guidelines but we are now proceeding with review of the Constitution with the expectation we will have a series of remits to put to delegates at next year's AGM.

After obtaining comments from members and Clubs regarding our website and database we identified areas where change would be useful and we then sought guidance and costings from the original designer and developer of our systems. These desired changes have been distilled to items the executive consider are absolute essentials to maintain ease of administration at National, Zone, and Club levels without going crazy with development of new systems; The costs associated with these enhancements have been quoted at approximately \$7,000 and we intend to proceed with these shortly.

Land access agreements continue to be a concern for NZFWDA and our member Clubs.

I have previously reported on two iconic tracks in the Coromandel and near Waihi and am saddened to report that NZFWDA has now abandoned our attempts to

manage access and maintenance of Waitawheta track owing to the unattainable consent requirements demanded by Environment Waikato. Sadly the negative environmental impacts the Regional Council were seeking to mitigate will now be worsened by the unregulated and unmanageable activities of users other than NZFWDA members.

Maratoto Track is currently closed to all users owing to DOC's concern around Kauri die back disease. We have no expectation of early resolution of this issue or when 4WD access might again be agreed.

As previously reported, I consider land access to be a primary area of attention need; in simple terms, without access our sport and recreation ceases. Obtaining and retaining access needs significantly greater emphasis but this cannot be done solely by National Executive; I believe we must mobilise all Clubs, Zones, and National under a common accord to secure, and retain formal and enduring land access agreements across all NZ. We cannot rely solely on goodwill from land owners / custodians; we must be proactive, develop and implement national and local relationships with land owners / custodians, formalize previously informal agreements, seek out new agreements, and be prepared to stand firm around issues of access. These are not times for complacency...

New Zealand Four Wheel Drive – National AGM. 20 May 2018 Northern Zone Presidents Annual Report for National AGM (Invercargill)

There is continuing pressure in Northern Zone on land for Four Wheeling. The increasing number of Four Wheel Drivers and those off-roading is adding pressure to the limited number of accessible sites, particularly for those in the Greater Auckland Area. The conduct of a few Four Wheelers, often those who are not members of the association, causes problems for the many.

1. (a) Looking back over the year I am reminded that in May 2017, in the North, we were hoping to have access to Waitawheta.

(b) We arranged work for Maratoto over Christmas 2017 and reopening of the Maratoto track after Christmas 2017. I received a draft Manager Insurers Agreement from DOC.

Maratoto

2. I sent the Agreement DOC required, being a Managers Insurers Maratoto contract, to DOC on 12 May 2017. I made the contract less onerous for a voluntary association with limited resources. It was not returned to me until 4 September 2017.

(a) By September 2017 there were issues about Kauri Dieback in the Waitakere Ranges in Auckland with tracks being closed. DOC started to survey all its tracks.

DOC had made a number of (b) changes to the draft Agreement but had not used "tracking" to show the changes. So I could not see the difference between the Agreement with the changes that I had made and the changes that DOC made subsequently. I worked through that, got approval from the National Executive and sent the Agreement back to DOC on 2 November 2017. (c) DOC sent me a letter (dated 4 December 2017) but only emailed to me on 19 March 2018 from Avi Holzapfel, the Operations Manager: DOC commented on our good (i) intentions to maintain the track. DOC felt there was a nervousness about our NZFWDA's ability to resource this.

(ii) This was at the same time as they advised that they were awaiting the outcome of a second inspection of the track and that the management agreement "does not reflect the arrangement that I wanted to see in place".

(d) I have replied to DOC stating my concern that the standard agreement is unduly onerous for a voluntary association and did not recognise our good work of the association members over many years. The management agreement seemed more suited to a business concession, i.e. traders rather than a voluntary association with limited resources, particularly given that:

(i) We are not the only group using the track and

(ii) The agreement would impose liability for users over whom we have no control.

(iii) I have told DOC.

(iv) Furthermore I am aware that DOC now has the new form of agreement that they are likely to require us to use.

(i) Maratoto is currently closed by DOC "temporarily with more information required because of Kauri dieback concerns". In any case it is normally closed at this time of year anyway (because it is winter).

Hull Road

3. Money that had been collected by New Zealand Off Roaders was paid over to NZFWDA and when the weather improved work was carried out by a contractor.

Waitawheta

4. Remains closed by DOC and Waikato Regional Council – I have heard that people keep going in and the track has got worse since the closure.

National Executive

5. (a) The National Executive has been very busy working on Health and Safety. In April this year alone we had three meetings (two of 2+ hours and one of 4+ hours).

(b) We are also seeking a list of roads of National significance;

(c) We have also discussed a volunteer register zone to record community work carried out by

association Clubs.

Other Matters

6. (a) There was an issue about Tow Locks, a device to use over tow-balls, and I wrote to members confirming that the Association does not approve or endorse them.
(b) I was asked to comment on the meaning of restrict and whether Juken NZ could close Fern Glen Road. My reply was restrict does not mean close but Juken could close temporarily.

7. At our Zone meeting in February we had a discussion about the AGM this year in Southern Zone and the Zone agreed to subsidise travel of Northern Zone delegates.

8. I would like to thank everyone in the Northern zone who has helped with various matters. As I have said previously we can only operate because of the time spent by many volunteers.

(a) In particular I would like to thank the Northern Zone Executive:
(i) Eileen who works tirelessly in the background;

(ii) The support of Russell de Luca, Zone PRO and Dave Brown, Zone Vice President;

(b) The National Executive is working well. There are likely to be changes this year because the National Secretary Bobbie Kincaid is standing down and so are the Southern Zone President Russell Quin, our insurance guru and PRO John McDonald.

(c) I am thankful for my secretaries' help, without whom my job would be much more onerous.

(d) Thank you to all of you that realise that sometimes I can't always do things as quickly as others might want. It remains an honour to serve you.

(e) I would also like to acknowledge all Northern Zone Delegates for their support and for appointment of me to represent them in the Northern Zone.

The 42 Traverse continues to need work and a number of ways to provide finance have been worked though during the year.

Central Zone has moved its meeting venue from the Cosmopolitan Club to club rooms owned by the local Amateur Radio Society and this is considered by all to be a far more suitable meeting venue where we are not competing with a 100 other diners noise, the bar and pokie machines. The costs work out to be a few dollars cheaper and we are able to contribute the Amateur Radio Society financially.

This year Central Zone set aside a pool of money to assist people to attend the

National Conference, 3 Clubs have taken up this offer.

Finance

Several busy years have depleted our "cash on hand" figures and next year we will need to be dipping in to reserves to continue to operate. We in Central Zone have worked over the last few years to ensure our members see something tangible for their fees so we work hard to provide events and minimal cost to members, and assist with track work when ever possible.

This depletion of funds at Zone level has resulted in a number of Clubs supporting an increase to the Zone split and the Affiliation fee to ensure continuing funding.

I recently attended the NZFWDA AGM in Invercargill, it was well worth the trip. I was one of the few that hadn't been to Invercargill or that far south before so stayed a couple of extra nights and hired a car to look around.

We all enjoyed the organised trip to the fantastic truck & motorcycle museums, Burt Monroe display and trip with Southland LR Club, their play area is leased from the local council and a great spot to learn and test your off road skills. The weekend showed the importance of AGMs being shared around and need for this to continue, it gives the local Clubs and Zones a chance to show the rest of the country what they have on their back door. I would like to thank Russell Quin for all the time he put into organising the event and for his continued work at National and Southern Zone levels.

I have been hearing whispers about next years AGM which will be in the Manawatu and what is planned. So put 25/26 May 2019 your calendar and bring your 4x4.

Whangamomona Road From May to October the old Whangamomona Road is closed in the winter to the 4x4 Clubs as requested by Stratford District Council (SDC) to help save the road. In April the SDC sent workers in to repair and check the bridges on the old Whangamomona Road, this was successful but unfortunately afterwards the recent weather/storms have caused damage and slips to the road. At this stage we have no word when the road will reopen, as the SDC will not be assessing it until after the winter.

Santoft Forest

After a recent request for review of the forestry insurance and how it covers the Clubs. It has been confirmed we have \$10 million public liability, so this should give Clubs access to many places where land owners are requesting higher coverage (insurance certificate is on the NZFWDA website for downloading). Due to the increase to the insurance and the new act, Manawatu Club have negotiated limited key access to Santoft Forest, (located between Turakina & Rangitikei rivers (Bulls/ Scotts Ferry) along the coast). Santoft Station was bought by the government for forestry development and Returned-Soldier settlement after

the Second World War. Sambar deer were introduced in 1875 from Sri Lanka. Today they are a protected herd, controlled by balloted hunting within a limited season. If any Club would like a trip through there please contact Manawatu or Wanganui Clubs for access or joint trips.

Please note last year the Forest and Rural Fires Act 1977: was repealed, on 1 July 2017, by section 195(b) of the Fire and Emergency New Zealand Act 2017 (2017 No 17). There have been many changes, so don't just assume the old rules apply.

Central Zone Jamboree 2019 Plans are well underway for a bigger and better 2019 Jamboree in Ashhurst, Manawatu. There will be new trips and places to see as well as being a great atmosphere and socialising, so mark Wellington Anniversary weekend 2019 in your calendar. Places will be limited.
