NZFWDA AGM 2020

Held 7 November via Zoom

The AGM had a slow registration process this year while we accepted everyone in to the Zoom meeting, giving instructions on how the voting would work as we went. Zoom is an interesting environment.

We had 23 Clubs represented by 32 delegates (23 delegates were preregistered). Not bad for our first ever electronic AGM! In comparison, at a face to face AGM last year, we had 40 delegates representing 19 clubs.

Neville started the meeting with a rundown of how Covid-19 has affected the AGM process and specifically the requirements of the COVID-19 Response (Requirements for Entities - Modifications and Exemptions) Act 2020. Following advice, the Executive had determined they were unable to certify that the integrity of the voting process could be substantially complied with or that all persons who were entitled to vote would have a reasonable opportunity to vote and participate in respect to:

- Alterations of rules thus Constitution remits to be rolled over to 2021 AGM.
- Election of Officers of the Association - appropriate to defer any elections until 2021 AGM. There had been one nomination for the National PRO position received just 7 days prior to the Zoom AGM and, given the impracticalities of meeting the requirements of the above mentioned COVID-19 Response Act 2020, it was agreed that nomination would also be held

over until 2021 AGM.

The Zoom meeting agenda had therefore been set up for Housekeeping purposes to:

- give final approval to the 31 March 2019 Financial Accounts
- Approve the 31 December 2019 Financial Accounts
- Receive the Reports of the Zones and Executive
- Ratify the appointment of Markham's to compile and review the Financial Statement for the full year to 31 December 2020
- Approve the roll over of the existing National Executive, namely
 - Neville Dunton President
 - Grant Purdie Public Relations Officer
 - Kath Jaggard Secretary
 - Joanna Lilford Treasurer
- Ratify the 2020 appointed Zone Executives and the National Competitions Officer
- Ratify the roll over of Affiliation Fees, Pro-rata fees, Zone Split and Application fees for the 2021/2022 membership year.
- Confirm the next AGM to be held in Wellington at the end of May 2021.

In all, it was a successful meeting and we thank all participants for making it so successful. We are really looking forward to getting back to a face to face AGM in Wellington next year.

42 Traverse Maintenance

The 42 Traverse is an old logging road across the Tongariro Forest almost in the centre of the North Island... not exactly, as that point can be found not too far away in the Pureora Forest.

Back in 2000 when the Department of Conservation (DOC) were creating their 'Conservation Management Strategies' (CMS) for the various conservancies, their draft document eliminated vehicle use in all the Tongariro/ Taupo Conservancy lands. Most historical vehicle routes were arbitrarily closed! Among them was the 42 Traverse which, although neglected by DOC, was a popular off-road route of around 40 kilometres that was largely kept open by occasional 4x4 use and hunters.

Several Taupo 4WD Club members undertook to argue DOC's position and with NZFWDA help they finally managed to get a review in 2005 after intervention by the NZ Conservation Authority.

The 42 Traverse agreement introduced a seasonal closure to 4WD's and required a review of the condition of the route after two years. Anecdotally it was understood that several senior DOC staff were confident that damage to the route by vehicles was a foregone conclusion and the route could then be closed permanently.

Fortunately, they were wrong and today the route is in better condition than back in 2005. A formal review by DOC was never done, possibly because it would have looked bad to have been wrong.

Supposedly those CMS are a 10 year statutory document, but that Tongariro one is now 15 years old and not yet publicly scheduled for review.

To ensure that DOC could not easily come up with the excuse of a lack of maintenance on the 42 Traverse to again suggest closing to vehicle use in a future CMS, the group 'Friends of 42 Traverse Inc. was formed in 2016 to assist with ongoing maintenance, such as keeping the ever growing vegetation under some control. Originally the intent was to create a 'partnership' agreement with DOC but despite four years of discussion and several versions of formal agreement on the table, DOC deferred on signing. A formal agreement would have allowed direct fund raising through a variety of sources to allow paying contractors to do maintenance, but without that agreement those options evaporated, so it was back to a practical 'hands on' situation of organizing volunteers to manually cut back the encroaching vegetation.

This year, despite COVID-19 there were two 'cut backs' organized, one back in June and the second on 21 November. Both were well supported by the 4WD community primarily, with the latest having more than 30 volunteers in action. As a result, there is currently around 30 kilometres of off-road track with significantly less risk of vegetation 'pin striping' vehicle paintwork... the view ahead is better too.

These efforts to look after the few public lands that we are allowed to utilse for our recreation are valuable in a variety of ways and contribute to better relationships by bringing together a variety of volunteers. At the recent cut back, we had a family with a couple of teenage boys with an interest in four wheeling (driving a Nissan Terrano) and who'd once cycled the 42 Traverse. I subsequently had a note from their mother...

"It was such an awesome day, and we would not have been able to do it without you and the team of great people that were there on the day.

One thing I was blown away by was the time, conversation and advice that was shared with 'A' and with a special thanks to the guys who supported him to have a go at the incline after the river. It was actually 'A's' 17th birthday and you all made it one special day. On a personal note it was great to give back to such a beautiful area and for all the people who ride through, whatever their mode of transport! "

We had help from near and far, with great support from the King Country 4WD Club, the Hawkes Bay, Rotorua, Taranaki, Auckland and south to Wellington. Thank you to everyone who has volunteered this year!

A collapsing culvert that could endanger users was identified during the November cut back and it is possible that the 42 Traverse may not open on 1 December for through traffic as repairs could take a while.

Round One, Wairarapa



On a wet and windy Saturday morning over 30 vehicles and about 50 or so club members turned out on the South Coast to do their annual cleanup. Nothing special for this club, Cross Country Vehicle Club (CCVC) spends a lot of time on the South Coast, not only enjoying some unique 4wd challenges but also doing track maintenance, replanting dunes, assisting the council rangers and police with visitor education, and maintaining Capital Kiwi's traplines through Te Kopahou Reserve.

Well, it turns out that this day was a bit special as it kicked off with speeches from the NZFWDA's (and CCVC's) Grant Purdie, who is the National PRO, Wellington Mayor Andy Foster, old mate Rob Goulden (ex-City Councilor) and our kaumatua of the coast Barry Insull, all to mark the 20th anniversary of the CCVC beach cleanup, brilliant.

People toiled out in the weather for a few hours hauling in a ute load of trash for Ranger Frank to get rid of including somebody's stockpile of pallets for firewood and the usual tyres and glass. This year the team also had to deal with a much - increased number of dog-poo bags, not nice, what a pity these dog owners lack a sense of civic pride and personal responsibility. While today's beach cleanup was on the South Coast, from the visitor centre to the mouth of the Karori Stream (a distance of about 7 or 8 km), CCVC also does regular cleanups on the Eastbourne coast and some of the bays on the nearby vast Terawhiti Station south of Makara beach.

As well, CCVC's South Coast replanting has been happening for the last 15 years, yet another ongoing opportunity for CCVC to support the Council and community on the coast. The most recent effort has been to install Capital Kiwi's trap lines throughout Te Kopahou Reserve and the South Coast and then maintain them every three weeks. Current results are over 100 stoats and weasels in addition to the rats, mice, possums and hedgehogs. Safety **Incidents**

If there is an incident during any 4wd club trip or event, the club now has an obligation to report it to the NZFWDA Executive. This applies to any significant accident or incident and/or death or serious injury.

Prompt initial advice is best, with further details at later dates once the club has investigated and formed any conclusions.

It's great to acknowledge that one club has already started down this track with a recent injury accident.

This new obligation for clubs was approved by a remit at the 2019 AGM.

Why do we need LVV Certification?

An all too common question. In a nutshell, the NZ Government requires that all vehicles meet applicable safety requirements. Once a vehicle is modified from it's original state or is scratch-built, there needs to be a method of ensuring continued compliance.

The LVV certification system is necessary because it is not practical to test individual or low-volume modifications and construction features against the expensive test processes required by the international standards which apply to high-volume production vehicles.

The purpose of the low volume vehicle certification system, therefore, is to

ensure that all modified production vehicles - whether modified for commercial, passenger service, disability, recreational, leisure, sporting, or compliance purposes - and scratch-built vehicles, have been designed and constructed in such a way that they are safe to be operated on the road, and comply as closely as practicable with the legal safety requirements applicable to high volume production vehicles.

Northern Zone President Report

Our last Quarterly meeting was on Saturday 15 February 2020.

Since then there have been 2 lockdowns in Auckland and those restrictions has meant that it has not been possible to have a meeting until September at the Huntly RSA.

Maratoto

The track was open before Christmas until it was closed at the beginning of the first Covid-19 Lockdown (it closes for winter each year anyway). A Community Agreement with DOC was signed by me and agreement reached on that on 3 September 2019. The track is, subject to the weather, open.

Club Membership of the Four Wheel Drive Association

It has been suggested to me that there are several clubs that have joined the Association but not all the members have paid up. If a club is not an incorporated society, my understanding of matters is that each member of the club is personally liable for anything the club members might do.

If an unincorporated club's members go out on a run with more people who might be called members who have not paid membership fees, those members are not likely to be covered by the Association's insurance. So if something goes wrong, they could be prosecuted and maybe all could be prosecuted?.

Off Road Tracks

Shortly before the first Lockdown there was an issue about two clubs who use tracks in the same area. One club was threatening to issue trespass notices to the other. I spoke to the Presidents of both clubs to see if we could have a meeting to discuss matters. With the Covid-19 Lockdown that meeting did not happen: We are in this together. The reduction in access we are all facing makes each club's tracks more valuable to them. At the same time I suggest we need to work together as clubs to

sort out problems and to promote four wheeling and sharing of tracks, on a reasonable basis.

It is not a good look if there are fights between clubs. There is enough criticism of four-wheel drivers without us causing trouble for each other. Thankfully in this case I understand matters have now been resolved.

Covid-19

The major event of the last 18 months is of course the Covid-19 Pandemic. You will know how it changed everything. The Association National Executive continued to meet, often by Zoom on a very regular basis.

The National Executive

The Association AGM was rescheduled as a Zoom only meeting to meet statutory requirements on Saturday 7 November 2020. What that meant was a shortened agenda and no amendments to the Constitution this year. The meeting lacked the debate of an ordinary face to face meeting.

Hull Road

I made submissions on your behalf supporting temporary winter closure so it can be open September to May.

90 Mile Beach Management Plan

Russell de Luca has provided a report. According to him, most of the land adjoining the beach is Maori land and that all documents envisage specific provision to be made for continuing four wheel drive access to the Beach at various points. Russell also offered to draft a response.

Thank you to everybody in Zone who has helped over the last 18 months. As I have said before the Association can only operate because of the time spent by many volunteers. Eileen works tirelessly; Russell as PRO always has a good understanding of matters. We have had some

interesting debates. Russell is standing down this year and I will miss his valuable contributions and understanding on matters. VP Dave Brown provides a solid backup.

DIDYMO

Didymosphenia has large sarcophagus-shaped cells that are mounted on long mucilaginous stalks. Masses of this alga (commonly referred to as "didymo" or "rock snot"), primarily consisting of the stalks, can smother streambeds, and pile up along stream and river margins. Dried-up wads of this alga look like paper pulp dumped on the stream/river banks.

Clean all gear when moving between waterways

Freshwater pests, including didymo, could squeeze the life out of our country's most precious rivers and lakes. They can be spread by a single drop of water or plant fragment. You can help to protect your favourite waterways if you always check, clean, then dry any equipment that comes into contact with the water, between every waterway, every time.

The South Island is a controlled area


The South Island is a controlled area for didymo. This makes it a legal requirement to clean all gear used in the water before going from one waterway to another.

Cleaning Vehicles

Vehicles and tyres can be cleaned using a treatment solution, by drying, or using a commercial carwash with an underside spray.

If using a treatment solution:

- Carefully check tyre tread for clumps of algae and other debris.
- Clean the vehicle thoroughly with a treatment solution, leaving it on for at least one minute.
- Spray the underside of the vehicle and any other parts that have had contact with river or lake water.
- Rinse off with town water supply.



The Check, Clean, Dry method

To prevent the spread of freshwater pests (like didymo), whenever you move between waterways you must check, clean and dry all your gear that comes into contact with water. If you don't want to treat your gear, make sure you only use it in one waterway.

Check

Remove any plant matter from your gear and leave it at the site (the river or lake bank), or put it in the rubbish. Don't wash plant material down any drain.

Clean

There's more than one option for cleaning your gear – choose the one that's best for your situation and your gear.

Cleaning options

OPTION	AMOUNT	TREATMENT TIME ²
Dishwashing detergent or nappy cleaner	5% solution (500mls diluted to 10 litres in water)	Soak or spray all surfaces for at least 1 minute
Bleach	2% solution (200mls diluted to 10 litres in water)	Soak or spray all surfaces for at least 1 minute
Hot water ¹	Above 60°C	Soak for at least 1 minute
	Above 45°C	Soak for at least 20 minutes
Freezing		Until solid

¹ 60°C – hotter than most tap water; 45°C – uncomfortable to touch

Ensure your gear is completely dry to touch, inside and out, then leave dry for at least another 48 hours before you use it (didymo can survive for months on moist gear).

To report a suspected didymo sighting, call the MPI Biosecurity NZ exotic pest hotline on 0800 80 99 66.

DISPOSE OF HUMAN WASTE



GO BEFORE YOU GO

Use the facilities at your home base before heading out so as to try and avoid having to go while out.



DO YOUR RESEARCH

Check out the webpage of the specific site you intend to go to or call the land management office to find out what facilities exist and are open.



USE FACILITIES

Use existing facilities if open, but bring your own toilet paper and hand sanitizer as many locations may not be stocked.



KNOW WHERE TO GO

If facilities are not available, make sure you are 200 feet (70 big steps) from water, campsites and trails for urine; for poop, pack out your waste by using a human waste pack out kit such as a WAG bag.



DISPOSE OF WASTE

If you can't pack it out, bury human waste 6 to 8" deep, 200 feet from water, campsites and trails. If packing out your toilet paper is not possible, bury it deeply in the hole.



PACK IT OUT

Pack out ALL wipes and sanitary products as well as any trash.

Road Show 2021 - Event Regulations

Dear fellow 4-wheelers Re: regulations defining events

As you should all be aware the Wellington Regional Council prosecuted Valley Four Wheel Drive Club and the NZFWDA for RMA breaches during a November 2018 trials competition event. Both Club and NZFWDA were convicted and substantial fines and costs were incurred. Our liability and legal defence insurance policies responded by covering all costs (less applicable excesses) but, on renewal early this year, our insurers clarified that availability of cover was for "sanctioned events" ie events undertaken by Clubs / Zones / or Association and formally recorded as such. Historically, events have been recorded in various ways but the National Executive were concerned there was no real formality around definition of events which meant that clubs / members might end up not being covered in the future if their activities were not accepted by our insurers as "sanctioned events". The National Executive realised that definition(s) of events was

needed. Ordinarily these matters would have been dealt with by way of Constitutional Remits considered and resolved at either a Special or Annual General Meeting. COVID-19 restrictions made it difficult for us to hold an in-person General Meeting.

The Executive considered definitions of "sanctioned events" were immediately required and in absence of any way to pass these definitions via Special or Annual General Meetings we exercised the powers given in our Constitution to introduce Regulations. The use of Regulations meant we could make rules quickly and we can update them if needed. Accordingly new Regulations were unanimously approved by your executive and have been published effective July 2020.

I note that to date we have had one individual member and three Clubs who have objected to the Executive making regulations, despite the Constitutional powers so to do; we are not aware of any criticism of the content of the regulations but it may be appropriate for these matters

to be reviewed at the next AGM or alternatively we could consider a new remit to provide that Regulations be ratified at next AGM (with or without changes), or lapse.

We hope the regulations strike the right balance between the needs and wishes of members whilst also ensuring continuation of our various liability insurance covers. A number of associated remits were approved for consideration at the 2020 AGM but as we were unable to hold a compliant face to face AGM this year these have all been deferred to 2021 AGM.

We believe it is important that the Remits and Regulations are explained and members views obtained. The Executive is planning a roadshow around Zones early 2021 to do this which may entail holding a forum during Zone meetings, or it may take some other form. Details to be advised as soon as we can work out the appropriate approach and timetable.





The maximum speed of a car during the early years (back in 1769) was 4km per hour!


